


# NSW Aboriginal Land Rights Act 1983 Education and Training Program

The Aboriginal Land Rights Act 1983 (ALRA)


Education and Training Program
is a specific response to recommendation
three of the performance audit report 2022
which states, "DPC should implement, in
partnership with NSWALC, an education
program that enhances understanding of
the Act and its operations."

The goal of the education and training program is to transform the current land claims process by improving understanding, practice, relationship, resourcing, and knowledge of the ALRA amongst government agencies who are directly involved in land claims.

#### Learning Outcome

Upon completing this training program, participants will acquire the understanding, knowledge, and abilities to apply the ALRA legislation and the land claims process to achieve the best possible outcomes for local Aboriginal communities.





#### Training Modules

The training program is made up of three modules which complement each other.

For each module, there are four topic areas which will have specific activities linked to learning outcomes.
