Would you like assistance managing your forest?

Local Land Services is seeking Expressions of Interest (EOI) from landholders to participate in the NSW Forest Stewardship Pilot which combines expert advice and incentives to support landholders to manage their forests for long-term sustainability.

What is forest stewardship?

Forest stewardship refers to long-term and site-specific management that supports many forest values and opportunities such as biodiversity, cultural assets, tourism and recreation, timber resources and products, and soil and water conservation. Stewardship can support multiple forest uses and does not need to be complex to be beneficial.

What is the pilot?

The Pilot offers assistance to landholders to:

- improve environmental, cultural, social and productive outcomes of private forests
- diversify the productive value of land and sustainable development of the timber industry
- foster Aboriginal forest values, practices and engagement
- collaborate with forest managers and engage in partnerships with the private and public sector
- use active and adaptive management for continual improvement and longterm forest stewardship
- improve understanding of farm forests in NSW through monitoring, research and innovation.

Who can participate?

To participate, landholders with forested land will need to meet the key eligibility criteria. Any landholders who meet the criteria are encouraged to apply, including those new to farm forestry, those experiencing significant challenges in forest management, and Aboriginal forest managers.

How will it work?

The Pilot is delivered by Local Land Services over 2022-24 and overseen by a Panel of forest management experts. The Panel provides advice on a range of issues including sustainable forest management, whole-of-property planning, silviculture and biodiversity.

Findings from the Pilot will be used to guide future support for private forests managers in NSW. See more detailed information in the Forest Stewardship Guidelines.

How do I apply?

Eligible landholders are invited to submit this EOI and can seek advice from Local Land Services and the Expert Panel during the assessment process. All applications will be assessed by the Panel against the Pilot objectives.

To be eligible, landholders must have:

- a forest area that is at least 10 hectares in size
- an existing Private Native Forestry Plan (PNF Plan) or is willing to obtain a PNF Plan
- clear and achievable forest management objectives
- ability and willingness to undertake forest management for environmental, cultural, social and/or productive outcomes
- willingness to consider partnerships, collaboration, or co-contributions.

Approved applicants will co-design a Forest Stewardship Agreement with matched incentives to help achieve their objectives. Incentives can include advice, technical assistance, and funding for forest management activities.

EOIs open on Tuesday, 4 October and close **Tuesday, 15 November at 5pm**.
